Payment Options and Due Dates			
<p>There are three payment options. Payment may be made in one single installment on August 1, 2018. In the alternative, payment may be made before the start of each term, with the first payment being due on August 1, and the second payment due on December 1. Finally, in order to assist families who would like a more flexible payment schedule, there is a ten-payment plan. Both the two-payment and ten-payment plans are subject to a 5% interest charge on the unpaid balance. Please note: These are the only payment plan options. Parents must elect one of these three plans when returning the enrollment contract.</p>

Methods of Payment and Late Fees		
	Method of Payment	Late Fee/ Dishonoured Cheques
Options A & B	Payment may be made by check or credit card.	1.5% on unpaid balance of tuition and fees Dishonoured cheques and refused credit card charges will be subject to a \$35 bank fee.
Option C	Payment may be made by credit card or check. Families opting to use a credit card must complete the credit card authorization form. Families desiring to pay by check must deliver ten post-dated checks to the school office no later than May 1, 2017.	Dishonoured cheques and refused credit card charges will be subject to a \$35 bank fee.

After-School Programme Fees	Outstanding Balances
Registration for after-school programs will take place during the month of August. After-school fees are due in advance each month and will be payable on the first of the month (for example, September after-school fees will be due on September 1. Students with outstanding after-school per fees will not be permitted to remain in after-school programs with unpaid balances.	All tuition and fee accounts must be paid in full by the end of each school term. Students with unpaid accounts on December 15, 2017, will not be permitted to attend class in January. Similarly, students with unpaid balances as of March 15, will not be permitted to return after the Easter vacation.

Once we receive your election, we will provide a bill reflecting the payment plan chosen and the due dates and payments required.
